THE CUSTOMS (MISCELLANEOUS FEES) NOTIFICATION 1998

The Customs (Miscellaneous Fees) Notification 1998 shall come into operation on 15 Apr 98. Under the Notification, the revised rate of following types of customs services are listed below:

a	Certification of landing certificates, true copies of customs permits and any such other documents as the Director-General may determine	\$12 per document
b	Copies of statements supplied to defence counsel	\$33 per document
c	Attendance of officers of customs in connection with –

	ii destruction of goods	\$55 per hour or part thereof per continuous operation.
	iii survey and destruction of goods	\$55 per hour or part thereof per continuous operation.
d	Attendance of an officer of customs in connection with –	
	i the stuffing and unstuffing containers	\$27 per hour or part thereof per continuous operation.
	ii The bottling, blending, compounding, varying or denaturing of intoxicating liquors in a licensed warehouse	- do -
	iii The reconditioning of liquors and tobacco in bond at the request of the owner or his agent	- do -

iv The packing and if necessary, the sealing of cases and packages of duty-paid goods for re-export under drawback	- do -
v Operations in premises not licensed under the Act.	- do -
vi Such other act or service requiring the attendance of officers of customs as the Director-General may determine	- do -
e Escort of vehicles, containers or craft conveying dutiable or other goods as the Director-General may determine	\$27 per hour or part thereof per continuous operation.
f Attending to enquiries relating to the classification of any goods for the purposes of the Act	\$55 per item of goods in respect of which enquiry is made.
g Attendance of an officer of customs in connection with –	
i the extension of opening hours in respect of customs offices, licensed factory warehouses, licensed warehouses, bottling warehouses, licensed distilleries, breweries, tobacco factories and other licensed factories for the manufacture of dutiable goods and container freight stations; or	Additional \$27 per hour or part thereof per continuous operation.
ii the stuffing, unstuffing or any operation at any place beyond the hours specified	Additional \$27 per hour or part thereof per continuous operation.
