LAUNCH OF TRAINING PROGRAMMES - SC 100 BASICS OF EVERY DECLARANT AND SC 200 STRATEGIC GOODS CONTROL PROGRAMME

- We are pleased to inform that we will be launching two new training programmes - SC 100 Basics of Every Declarant and SC 200 Strategic Goods Control Programme – with effect from February 2012. These programmes are organised by modules to enable participants to sign up for **either individual modules or as a package**. These programmes will be administered by Singapore Customs and conducted at Revenue House.
- Consequently, the existing Customs Competency Programme for Businesses I & II and Strategic Goods Control Programme for Businesses administered by Container Depot Association (Singapore) will be discontinued with immediate effect.
