**TO EXPEDITE CARGO CLEARANCE AT CHANGI FTZ CHECKPOINT**

Very often, air cargo agents produce to the Checkpoint Officers at Changi FTZ, a stack of Cargo Clearance Permits (CCPs) for consignments that require different clearance procedures. The consignments may be for sealing by Customs, or endorsement on CCPs, including those involving partial releases. As these CCPs are mixed together, there could be occasions when the cargo agents fail to inform the Checkpoint Officers of the specific requirements of the permits.

2 To overcome the problems, we have designed a form ( please see Annex) to help the cargo agents to segregate the CCPs, so that all the necessary action can be met without any delay. Besides enhancing the expeditious clearance of cargo at the checkpoint, the form could also serve as a checklist for the cargo agents to ensure compliance with the import requirements, e.g. they could check to ensure that bank payment slips are attached for permits under G1 condition.

3 With effect from 1 May 96, consignments that require any special Customs attention, as indicated in the CCPs, are to be accompanied by this form. If you have any doubts, please contact Checkpoint Officer, Mr Lian Wee Leong at telephone No. 5459124 .
