CLOSING OF SINGAPORE CUSTOMS AIR CARGO STATION

With effect from 1 Mar 2006, Singapore Customs (SC) Air Cargo Station at Changi Airfreight Centre (CAC) will be closed. The following new procedures would take effect on the same day.

Collection of Certificate of Origin

2 Traders and declaring agents may collect the Certificates of Origin (CO) at SAAA, an appointed collection centre of SC. SAAA is located at Room 107, Ground Floor, SATS Airfreight Terminal 3, Core H, Changi Airfreight Centre, Singapore 819455 (Contact No.: 65459597). In providing this service, SAAA will be charging an additional fee of \$6.00 per CO.

3 However, the additional fee of \$6.00 per CO is not payable, if you choose to collect the CO at CrimsonLogic Service Bureau, 230 Victoria Street, #07-02, Bugis Junction Office Tower, Singapore 188024 (Contact No.: 6339 0798). For this, you will need to declare the Application Product Type as "NH" instead of "NA" when you make your TradeNet declaration.

Amendments of Permits

4 Applications for amendments of permits should be made electronically through the TradeNet® before cargo clearance. If there are valid reasons for urgent amendments of permits after office hours, traders and agents may submit applications to the SC Office at Changi Terminal 2 (telephone no. 65464656) by fax at fax no. 65452204.
