STRATEGIC GOODS (CONTROL) ACT**(CHAPTER 300)****STRATEGIC GOODS (CONTROL) (BROKERING) ORDER 2007**

In exercise of the powers conferred by section 6 (2) (a) of the Strategic Goods (Control) Act, the Minister for Trade and Industry hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Strategic Goods (Control) (Brokering) Order 2007 and shall come into operation on 1st January 2008.

Application of section 6 (1) of Act

2. Section 6 (1) of the Act applies to all goods specified in Category Codes —

(a) ML1 to ML4;

(b) ML8.a.1., 2., 3., 4., 5., 7., 10., 11., 13.a., 13.c., 15., 18., 19., 20., 21., 23., 26., 27., 28., 32.j., 33., 34.;

(c) ML8.b.1. to 5.;

(d) ML8.c.1., 3. to 9.;

(e) ML8.d.1., 2., 3., 5., 6., 8., 9., 10.;

(f) ML8.e.1. to 6., 8. to 13., 15. to 18.;

(g) ML8.f.; and

(h) ML8.g.,
in Division 2 of Part I of the Schedule to the Strategic Goods (Control) Order 2007 (G.N. No. S 639/2007).
