UPDATES TO CUSTOMS CIRCULAR NO. 15/2017 LIVE OPERATION OF THE ASEAN SINGLE WINDOW (ASW) FOR THE ELECTRONIC EXCHANGE OF FORM D UNDER THE ASEAN TRADE IN GOODS AGREEMENT OF THE ASEAN FREE TRADE AREA ("ATIGA")

We have posted updates to ***Circular No. 15/2017: Live Operation of the ASEAN Single Window (ASW) for the Electronic Exchange of Form D under the ASEAN Trade in Good Agreement of the ASEAN Free Trade Area ("ATIGA")*** issued on 9 Nov 2017.

3 With effect from 1 April 2019, **Brunei Darussalam** will join **Indonesia, Malaysia, Singapore, Thailand** and **Viet Nam** to commence live operation of the ASW for the electronic exchange of Form D under the ATIGA.

How to apply for e-ATIGA Form D



Using e-ATIGA Form D in Back-to-Back Form D Application

Consignment must originate from one of the 5 other AMS participating

Ensure e-ATIGA Form D from the AMS is received in TradeNet

Indicate "Original e-ATIGA Form D Reference Number [XXX]" in 'remarks' column of the TradeNet declaration

Claiming Preferential Tariff Treatment locally using e-ATIGA Form D

Consignment must originate from Thailand

Indicate e-ATIGA Form D Reference Number as part of Supporting Documents
