GAZETTE OF THE STRATEGIC GOODS (CONTROL) (AMENDMENT) ORDER 2011

Singapore adopts the EU's export control list which is an amalgamation of the four multilateral export control regimes, namely the Wassenaar Arrangement (WA), the Australia Group (AG), the Missile Technology Control Regime (MTCR) and the Nuclear Suppliers Group (NSG). The four multilateral export control regimes have updated their export control lists and the EU will be revising their export control list to reflect these updates. Singapore will update its export control list upon release of the revised EU's control list.

2 As the recent updates of the four multilateral export control regimes' lists include a number of deregulated items, Singapore Customs has decided to review the control list, to incorporate deletions or relaxation of controls of some items in Singapore's export control list first, while pending the finalisation of the revised EU's export control list. In this regard, the Strategic Goods (Control) (Amendment) Order 2011 has been published and will take effect on 1 Jan 2012. The Amendment Order incorporates selected updates adopted by the four multilateral export control regimes.

3 Henceforth, traders are advised to refer to both the Strategic Goods (Control) (Amendment) Order 2011 and the Strategic Goods (Control) Order 2010 when referring to the export control list.
