### **FOUR MEN ARRESTED FOR EVADING ABOUT \$180,000 IN TAXES WITH MORE THAN 1,700 CARTONS OF DUTY-UNPAID CIGARETTES SEIZED**

Singapore, 12 June 2024 – On 7 June 2024, Singapore Customs seized 1,740 cartons of duty-unpaid cigarettes during an operation at Tuas View Crescent. The operation led to the arrest of four Malaysian men, aged 27 to 42, who were involved in transferring the illicit goods between a lorry and a van.

2 The lorry driver allegedly transported duty-unpaid cigarettes hidden amongst a legitimate consignment from Malaysia into Singapore, while the van driver and two others were allegedly engaged to collect the duty-unpaid cigarettes. The total duty and GST evaded was about \$188,241. All four men were charged in court on 8 June 2024.

3 Buying, selling, conveying, delivering, storing, keeping, possessing or dealing with duty-unpaid goods are serious offences under the Customs Act and the GST Act. Offenders can be fined up to 40 times the amount of duty and GST evaded and/or jailed for up to six years. Vehicles used in committing such offences are also subject to forfeiture.
