## SINGAPORE AND THE NETHERLANDS COLLABORATE TO ESTABLISH A CONTAINER TRACK AND TRACE SERVICE

Singapore, 18 April 2024 – Singapore Customs and the Customs Administration of the Netherlands (CAN) have formalised a collaborative effort with the signing of a Memorandum of Understanding (MOU) on 17 April 2024. This significant agreement, signed by Mr Lim Teck Leong, Deputy Director-General of Singapore Customs, and Mr. Frank Dijkstra, Chief Information Officer of CAN, marks the inception of a joint endeavour to establish a Container Track and Trace Service between the nations.

- 2 "This MOU is an important milestone, reflecting the growing partnership between Singapore Customs and the Customs Administration of the Netherlands to facilitate trade. It is our common goal to make trade between our countries seamless, fair and safe. We believe that traders from both sides will benefit from this joint effort as we continue to strengthen cooperation and boost cross-border trade," said Mr Lim.
- "The signing of this MOU marks another important step in the close collaboration between both our administrations. This MOU offers the legal framework for Customs to share data in a unique international partnership to facilitate trade between our countries and our ports. For the near future we hope to further strengthen and increase our close collaboration with Singapore Customs, on facilitation and enforcement, to make logistic flows seamless, trusted and efficient," said Mr Dijkstra.

4 Under this MOU, both customs administrations are set to collaborate closely in the

development of a Container Track and Trace Service, integrating data from various

sources including port and terminal operations, and customs-related events for

containerised shipments between the Port of Singapore and the Port of Rotterdam. To

ensure seamless integration and near real-time tracking, Singapore Customs and CAN

will collaborate with key stakeholders such as the Maritime & Port Authority of Singapore,

PSA Corporation Ltd, Port of Rotterdam, and Portbase.

5 The Container Track and Trace Service aims to provide importers and exporters

with enhanced visibility over their containerised cargo, enabling them to monitor its status

and location effortlessly as it traverses between Singapore and the Netherlands. This

heightened visibility empowers businesses to optimise their supply chain management

processes, leading to better decision-making and enhanced competitiveness in the global

market.

Mr Charles Lee, Ocean Product Head, Ceva Logistics Singapore Pte Ltd shared 6

that "The Track and Trace Service on the Networked Trade Platform (NTP) completes

the missing puzzle of the whole supply chain. The service allows us to have real time

updates for inbound and outbound container details via NTP. This is a significant value-

add for traders and supply-chain managers like us."

This is Singapore's second agreement under the Track and Trace Service. In 7

2022, Singapore established a Container Track and Trace Service with the General

Administration of Customs of the People's Republic of China. This service, available on

the NTP, currently provides visibility between Singapore and two ports in China,

Yangshan port (Shanghai) and Qinzhou port (Guangxi), and will be expanded to other

Chinese ports in the coming year.

## **About Singapore Customs**




