**NO CHANGE TO STATUTORY FEE FOR PERMIT AND CERTIFICATE OF ORIGIN (CO) APPLICATIONS SUBMITTED VIA TRADENET**

We refer to the announcement made by CrimsonLogic Pte Ltd (TradeNet operator) on 1 Nov 2024 (refer to **Annex A**) on the adjustment of the processing and messaging fees for permit and Certificate of Origin (CO) applications submitted via TradeNet for processing.

2 We would like to inform you that the statutory fees for the following applications submitted via TradeNet for processing will **remain unchanged**:

- a) \$0.90 per permit application; and
- b) \$4.00 per CO application.

3 With the new processing and messaging fees that will take effect on **13 Nov 2024**, the typical costs of each TradeNet application will be as follows:

- a) Each permit application will cost about \$3.19 per application, which comprise:
  - i) \$0.21 messaging fee (adjusted from the current \$0.20 per application)
  - ii) \$2.08 processing fee (adjusted from the current \$1.98 per application)
  - iii) \$0.90 statutory fee
- b) Each CO application will cost about \$6.29 per application, which comprise:
  - i) \$0.21 messaging fee (adjusted from the current \$0.20 per application)
  - ii) \$2.08 processing fee (adjusted from the current \$1.98 per application)
  - iii) \$4.00 statutory fee
- c) Each CO application, together with a Customs export permit application, will cost about \$9.27 per application, which comprise:
  - i) \$0.21 messaging fee (adjusted from the current \$0.20 per application)
  - ii) Cost of each export permit application:
    - \$2.08 processing fee (adjusted from the current \$1.98 per application)

- \$0.90 statutory fee
- iii) Cost of each CO application:
- \$2.08 processing fee (adjusted from the current \$1.98 per application)
  - \$4.00 statutory fee
