**PLACE OF RELEASE/RECEIPT CODE FOR TUAS TERMINAL GATEWAY WEF 1  
OCT 2021**

The “Place of Release Code” or “Place of Receipt Code” field for the new Tuas Terminal Gateway (TTG) is “TZ”.

2 When submitting permit applications in TradeNet, you should declare “TZ” in the “Place of Release Code” or “Place of Receipt Code” field to cover the movement of goods released from or received into TTG, respectively.

**FAQs**

**Q1: What is Tuas Terminal Gateway (TTG)?**

**A1:** The new Tuas Terminal Gateway (TTG) is located at Tuas Port. It is a new sea checkpoint for cargo clearance.

When submitting permit applications in TradeNet, traders/declaring agents should declare “TZ” in the “Place of Release Code” or “Place of Receipt Code” field to cover the movement of goods released from or received into TTG, respectively.

**Q2: What is the difference between TTG and Tuas Checkpoint?**

**A2:** The TTG is located at Tuas Port. It is a new sea checkpoint. The Tuas Checkpoint is a checkpoint located at a different location from TTG.

The location code for TTG is “TZ”, while the location code for Tuas Checkpoint is “THQ”.

**Q3: Will TTG be replacing Tuas Checkpoint?**

**A3:** The checkpoint at Tuas still exists. TTG will not replace Tuas Checkpoint.

There are no changes to the location code “THQ” for Tuas Checkpoint.
