EXTENSION OF BANKER'S GUARANTEE NO. Field BG REF NO¹

We refer to the above-mentioned Guarantee issued by us on Field BG ISS DT² at the request of Field PRIN NAME³ (UEN: Field PRIN UEN⁴) ("Principal") in favour of Singapore Customs for the sum of Singapore Dollars Field BG AMT⁵ (\$ Field BG AMT NUM)⁶ ("Guaranteed Sum").

2 At the request of the Principal, and in consideration of your continued agreement at our request not to require the payment of the Guaranteed Sum from the Principal as security, we hereby extend the Expiry Date and Claim Due Date (being ninety (90) calendar days following the Expiry Date of the Guarantee) for the above-mentioned Guarantee as follows:

Original Expiry Date: Field OR EXP DT⁷
Amended Expiry Date: Field AM EXP DT⁸

Original Claim Due Date: Field OR CD DT⁹
Amended Claim Due Date: Field AM CD DT¹⁰

3 All other terms and warranties as set out in the above-mentioned Guarantee remain unchanged.

4 This amendment forms an integral part of the above-mentioned Guarantee.
