Why Upgrade TradeNet®?

1) Align to regional and international standards

- Align TradeNet® permit fields to WCO Data Model
- Implement World Customs Organisation (WCO)'s HS amendments and ASEAN Harmonized Tariff Nomenclature (AHTN) 2012

2) Introduce new Trade Facilitative Measures

e.g. Relax some amendment & cancellation rules

Key changes affecting STS Tier 2 and 3 shipments

- A. Implementation of ASEAN Harmonized Tariff Nomenclature 2012 (AHTN 2012)
 - Possible changes to HS codes of your products

- B. Introduction of new permit fields for identifying nature of transactions:
 - Customs Procedure Code (CPC)
 - Processing Codes (PC) 1, 2 and 3

Use of CPC and PC1, PC2 and PC3

For **Authorised Economic Operator (AEO)** shipments

CPC	PC1	PC2	PC3
AEO	Country Code of country that issues the AEO Number e.g. CA, KR, SG, JP	AEO Number	

Note

AEO Numbers are no longer declared:

- in the CA Licence Number field
- with prefix “AEOXX” (where XX refers to the code of the country that issued the AEO Number)

Use of CPC and PC1, PC2 and PC3

For Strategic Trade Scheme (STS) Tier 1 shipments

CPC	PC1	PC2	PC3
STS	STS1		

Note

In addition, you will continue to declare the **same information** in your strategic goods Tier 1 permit applications

Use of CPC and PC1, PC2 and PC3

For Strategic Trade Scheme (STS) Tier 2 shipments

STS	STS2	STS Tier 2 Permit Number	

Note

In addition, you will declare the Strategic Goods Product Code in the CA/SC Product Code field instead of the “Trader’s Remarks” field of the outward permit application

For exports of chemicals controlled by **NA(CWC)** under the Strategic Trade Scheme **(STS) Tier 1 Scheme**

In addition, you will declare the same information for **CWC** (E.g. **NA(CWC) Licence Number, NA(CWC) Product Code, Concentration**) and **STS Tier 1** permit applications

Use of CPC and PC1, PC2 and PC3

For exports of chemicals controlled by **NA(CWC)** under the Strategic Trade Scheme (**STS**) Tier 2 Scheme

CPC	PC1	PC2	PC3
STS and CWC	STS2	STS Tier 2 Permit Number	

Note:

In addition, you will provide the same information for **CWC** (E.g. **NA(CWC) Licence Number, NA(CWC) Product Code, Concentration**) and declare the **Strategic Goods product code** in the **CA/SC product code** field.

Use of CPC and PC1, PC2 and PC3

For exports of chemicals controlled by **NA(CWC)** under the Strategic Trade Scheme **(STS) Tier 3 Scheme**

CPC	PC1	PC2	PC3
STS and CWC	STS3	STS Tier 3 Permit Number	

Note

In addition, you will provide the same information for CWC (E.g. **NA(CWC) Licence Number, NA(CWC) Product Code, Concentration**) and declare the **Strategic Goods product code** in the **CA/SC product code** field.

Use of CPC and PC1, PC2 and PC3

For exports of non-strategic goods, and strategic goods (with approved product code DL5A002) under the Strategic Trade Scheme **(STS) Tier 2 Scheme**

CPC	PC1	PC2	PC3
STS	STS2	STS Tier 2 Permit Number	

Line item 1: CA/SC Product Code field

DL5A002

Line item 2: CA/SC Product Code field

*Note: Leave blank in the CA/SC Product Code field in Line item 2 for declaration of non-SGC goods

Use of CPC and PC1, PC2 and PC3

For exports of non-strategic goods, and strategic goods (with approved product code DL5A002) under the Strategic Trade Scheme **(STS) Tier 3 Scheme**

CPC	PC1	PC2	PC3
STS	STS3	STS Tier 3 Permit Number	

Line item 1: CA/SC Product Code field

DL5A002

Line item 2: CA/SC Product Code field

*Note: Leave blank in the CA/SC Product Code field in Line item 2 for declaration of non-SGC goods

Structure of CPC and PC1, PC2 and PC3

In each permit application, you may declare up to:

- 5 Customs Procedure Codes (CPC)
- 5 sets of Processing Codes (PC)1, PC2 and PC3 for each CPC

Multiple CPC and PC1, PC2 and PC3

E.g. For an export shipment of CWC chemicals approve under STS Tier 2 Scheme, by a STP-Plus exporter to a Japan AEO importer, following will be declared:

	CPC	PC1	PC2	PC3
1.	AEO	JP	123456	
		SG	987654	
2.	STS and CWC	STS2	T2xxxxxxP	

Exports of STS Tier 2/3 shipments involving Inter-gateway movements

E.g. For exports of STS Tier 2/3 shipments involving the need to move the products from one FTZ to another, coy should declare two separate permit applications as follows:

- 1st permit: Inter-gateway transshipment application
(Message/Declaration Type: **TNP-IGM**)
- 2nd permit: Outward permit application
(Message/Declaration Type: **OUT-DRT**) without inter-gateway movement

*Note: Please remember to fill up coy's STS Tier 2/3 permit information accordingly into the respective fields as required under TradeNet 4.1.

Other changes

- Declaration of Strategic Goods Product Codes in “CA/SC Product Code” field instead of “Trader’s Remarks” field
 - Do not declare the dots (if any) in between the SGC product codes issued in the approval letter e.g. SGC product code **DL6A001.a.1.d** should be declared as **DL6A001a1d**
- Permit No. Prefix will be **“XO”**
 - For TradeNet export permits approved for STS Tier 2 or STS Tier 3 permits

Relaxation of Amendment Rules

Amendments are allowed to be made for “Exporter Name” without amending the Exporter UEN

Original	Amendment
Exporter UEN = 123456	Exporter UEN = 123456
Exporter Name = ABC Pte Ltd	Exporter Name = ABCD Pte Ltd

Common Errors to Avoid



Common Errors to Avoid

1. Avoid declaring multiple STS Tier 2 permits or/and STS Tier 3 permits **within the same** TradeNet[®] permit application

STS	STS2	T2U1234R01P

Common Errors to Avoid

2. Avoid submitting **within the same** TradeNet[®] permit application:
 - Products approved under different STS Tier 2 permits
 - Products approved under different STS Tier 3 permits
 - Products approved under STS Tier 2 and STS Tier 3 permits

Common Errors to Avoid

3. Avoid declaring in ‘Processing Code 1’ field:

➤ spaces in between “STS2” or “STS3” e.g.

(a) STS_2

(b) S_TS2

(c) S_T_S_2

➤ space before “STS2” or “STS3” i.e.

(a) _STS2

(b) _STS3

➤ space after “STS2” or “STS3” i.e.

(a) STS2_

(b) STS3_

Common Errors to Avoid (cont'd)

4. Avoid declaring in “Processing Code 2” field:
 - an **expired** or **not yet effective** STS Tier 2 or STS Tier 3 permit number
 - a **wrong** STS Tier 2 or STS Tier 3 permit number for your SGC product codes

5. Avoid submitting more than 1 SGC product code for 1 HS item

6. Avoid declaring SGC product codes **not approved** under STS Tier 2 or STS Tier 3 permits

Implementation Schedule



Implementation Schedule

- Implementation of TradeNet[®] Version 4.1:
✓ 1 Jan 2012
- Parallel run of TradeNet[®] Versions 4.0 and 4.1:
✓ from 1 Dec 2011



NO Parallel Run for some transactions

Big bang cut-over to TradeNet[®] Version 4.1 on **19 Dec 2011**, for transactions, covering:

- Movement of goods for bonding into and releasing from licensed premises (except for Class 2 Yard and Container Freight Warehouses)
- Temporary Import Scheme
- Goods controlled by NA(CWC)

Which TradeNet® Version to declare in the Dec 2011?

- If your shipments fall under the “big bang cut over” transactions, declare:
 - TradeNet® Version 4.0 before 19 Dec 2011
 - TradeNet® Version 4.1 effective 19 Dec 2011
- If your shipments do not fall under the “big bang cut over” transactions, your declaring agents may submit either TradeNet® Version 4.0 or 4.1 applications

Summary of Changes

TradeNet[®] version 4.0

- **Trader's Remarks:**
STS Tier 2 or STS Tier 3
Permit Number
SGC Product Code
- **Permit No. Prefix for exports:**
e.g. OD, CA, OT, OO

TradeNet[®] version 4.1

- **Customs Procedure Code (CPC) :**
STS or STS and CWC
- **Processing Code 1:** STS2 or STS3
- **Processing Code 2:** STS Tier 2 or 3 Permit Number
- **CA/SC Product Code:** SGC Product Code (issued in letter – to be declared without the dots, if any)
- **Permit No. Prefix for exports:** XO
