CHANGES TO SUBMISSION PROCEDURES FOR RETURN OF SUPPORTING DOCUMENTS FOR SELECTED PERMITS VIA FORMSG

With effect from 1 December 2022, Customs will extend our e-services via FormSG to the submission of supporting documents for selected permits at the NTP website at www.ntp.gov.sg > Government Service > Voluntary Disclosures, Statements and Document Submissions > Return of Supporting Documents for Selected Permits:

- a) TradeNet Permit issued with permit conditions **Z02**, **Z06** or **Z18**; or
- b) TradeNet Permit queried by Permits Compliance Branch via letter references prefixed with S" (e.g., S19FQ00001, S19AR00003); or
- c) ACCESS permit queried by the Permits Compliance Branch of Singapore Customs.

2 There will be a one month transition period from 1 to 31 December 2022. Please note that the submission of supporting documents for such selected permits via NTP Data Repository will not be accepted after 31 December 2022.

3 Please refer to the list of Frequently Asked Questions (FAQs) in **Annex A** and the Quick Reference Guide in **Annex B**.

FREQUENTLY ASKED QUESTIONS

Q1: Can I continue to submit the supporting documents for the selected permits via NTP Data Repository after 31 December 2022?

A1: There will be a one month transition period from 1 to 31 December 2022. Please note that the submission of supporting documents for such selected permits via NTP Data Repository will not be accepted after **31 December 2022**. With effect from **1** January 2023, all supporting documents for TradeNet permits issued with Z02, Z06, and Z18 permit conditions; in response to TradeNet permit queries (letter references prefixed with "S" e.g., S19FQ00001); or ACCESS permit queries by Permit Compliance Branch (PCB) of Singapore Customs must be submitted via FormSG.

Q2: What is/are the acceptable file format(s), maximum file size and the number of files that I can upload onto the FormSG?

A2: Please compress your supporting documents (Commercial Invoice, Permit (CCP), Packing List, Airway Bill / Bill of Lading, CIDBC) in one zip folder, as you can only attach one file with maximum file size of 7MB for each FormSG submission.

If there are additional supporting documents that could not be attached, please submit another FormSG and indicate in the remarks the intended TradeNet Permit Number (e.g., IG1A123456A_2) or ACCESS HAWB Number (e.g., HAWB1234567_2).
