## OVER 2,500 CARTONS OF DUTY-UNPAID CIGARETTES SEIZED IN SINGAPORE CUSTOMS OPERATION

40-year-old Malaysian male arrested with two vehicles seized.

Singapore, 14 September 2023 – In its ongoing efforts to detect and deter tax evasion, Singapore Customs conducted an operation at a multi-storey carpark in Bukit Batok Street 24 on 7 September 2023.

- A man was seen transferring brown boxes from a van to an adjacent car. Officers conducted checks on the two vehicles and uncovered a total of 2,550 cartons of duty-unpaid cigarettes packed inside these brown boxes. The man, a Malaysian aged 40, was arrested. Both vehicles as well as the duty-unpaid cigarettes were seized.
- The total duty and Goods and Services Tax (GST) evaded in the duty-unpaid cigarettes amounted to \$272,952. Court proceedings are ongoing.
- Buying, selling, conveying, delivering, storing, keeping, possessing or dealing with duty-unpaid goods are serious offences under the Customs Act and the GST Act. Offenders can be fined up to 40 times the amount of duty and GST evaded and/or jailed for up to six years. Vehicles used in the commission of such offences are also liable to be forfeited.
