TRADENET ELECTRONIC AMENDMENT MODULE

In our continuous effort to provide better service to the trading community, we are pleased to announce that with effect from 29 May 2000, you will be able to apply for electronic amendments to the fields "Port of Loading" and "Country of Origin" for the types of permits and goods as specified in the following table:

Permit Type	Port of Loading	Country of Origin	Type of Goods Involved (Excluding controlled goods)
IG	Amendable	Amendable	All goods
IN, II – For storage of goods in Bonded Warehouse	Amendable	Amendable	Non-dutiable goods
IN, II – For storage of goods in Licensed Warehouse	Amendable	Not Amendable	Tobacco products, cars, motor cycles and motor scooters
IN, II – Temporary Import Scheme	Amendable	Amendable	Non-dutiable goods, cars, motor cycles and motor scooters

In summary, the electronic amendment to the two fields are allowed for permits taken out for inward consignments. Please note that you are still required to apply for manual amendment to these two fields, if the goods involved are controlled goods, such as medicines, primary products and liquors (except as specified above).

- I append hereunder for your information the prevailing conditions for submission of electronic amendments of permits:
 - The application must be made by the same company which declared the permit;
 - The application can only be made if the permit has not been used for cargo clearance.
 - A permit can be amended only four times electronically.
 - A maximum of 30 fields may be amended during each electronic amendment.
 - No electronic amendment is allowed if the earlier amendment was made manually. If further amendments are required for this permit, the trader may apply for manual amendment
