REGISTRATION OF TEXTILES AND TEXTILE GARMENTS SUB-CONTRACTORS

Introduction

Currently all textiles and textile garments manufacturers who are exporting textiles and textile garments to USA, EU and Canada must register with Singapore Customs. Upon registration, they must comply with the conditions of registration and textiles rules of origin before we can approve the exports. Registered textiles and textile garments manufacturers may sub-contract their principal operations such as cutting and sewing to a sub-contractor in Singapore. For sub-contracted exports, we require you to declare the name(s) of the sub-contractor(s) in the export declarations.

With effect from 15th September 2003, all sub-contractors who wish to provide subcontracting works to the registered textiles and textile garments manufacturers who intend to export textiles and textile garments to US, must register with Singapore Customs. The registered textiles and textile garments manufacturer who is the principal manufacturer will be responsible for the production of the textiles and textile garments locally and to furnish all the relevant production records relating to the export shipments.

We require you to inform your sub-contractors of the need to register with Singapore Customs. From 1st December 2003, we will reject applications for Certificates of Origin for textiles and textile garments exports to US if your sub-contractor is not registered. It is your responsibility as the principal manufacturer to ensure that the sub-contractors are registered for the products that you intend to export.

Procedures to Apply for Registration

We detail below the procedures for registration. All registered textiles and textile garments manufacturers who also provide sub-contracting works need not have to apply for registration as a sub-contractor.

Application Form for Submission

Application forms for Registration of Textiles and Textile Garments Sub-contractors are available at our website: http://www.tradenet.gov.sg. The sub-contractor will complete the application form (a copy is enclosed with this circular) and submit it to the Classification and Statistics Audit Branch (CSA) of Singapore Customs. One application is required for one sub-contractor and the sub-contractor must list the names of his principal manufacturers in the application.

Factory Visit

Upon receipt of the Application for Registration of Textiles and Textile Garments Subcontractor, Singapore Customs will visit the factory to assess that the company has the factory set-up, machinery, manpower to manufacture the products and that it keeps proper books and records of its operations. If the application is successful, we will issue a registration letter to the sub-contractor.

Approval and Renewal of Registration

The approval of the registration of sub-contractors is valid for 2 years. Sub-contractors who wish to remain registered with Singapore Customs must renew their registration before the expiry of the 2 years validity period. For renewal, the sub-contractor will return the Update of Registered Sub-contractor's Record that Singapore Customs will send to them. If no renewal is submitted within the stipulated timeframe, Singapore Customs will de-register the sub-contractor.
