Singapore Customs will launch its revamped website www.customs.gov.sg on 26 January 2007.

All existing e-Services such as WISE, PETROLink, MRS and online currency converter will be maintained and integrated into the new website. The new Singapore Customs website will thus become a truly one-stop portal for all customs- and trade-related exchanges.
