## REMINDER: CHANGES IN CLEARANCE PROCEDURES

Please refer to our Circular 11/2008 on the new cargo clearance procedure for unmanned places. To avoid unnecessary disruption to your business, please note that not all permits need to be faxed to Customs. You will only need to fax the permit to Customs at the specified facsimile number when the permit condition specifically indicates to do so.

## Faxing of permits with 'AZ' condition to Customs

2. When faxing the permits with 'AZ' condition to Customs, you are <u>not</u> required to attach any supporting documents nor the Circular 11/2008 to the permits.

- 3. Please ensure that the relevant information (*name*, *designation*/*signature*, *date/time* of landing at place of release) is correctly filled in the respective sections of the 'AZ' condition on the permit itself, before faxing the permit to Customs.
- 4. Customs will not issue acknowledgement of receipt for the faxed permits. To avoid unnecessary delay, please do not fax permits without the 'AZ' condition to the specified facsimile number.

## Clearance of goods for permits with 'J6A' and/or 'CB' condition

5 You are reminded that there is no need to bring the goods and/or the permit with condition(s) 'J6A' and/or 'CB' to the nearest checkpoint for clearance, nor fax such permits to Customs.
