**NEW LOCATION CODE “PT” FOR PENJURU TERMINAL**

The new Penjuru Terminal will commence its operations on **22 Jun 08**. This new terminal will replace the existing Pasir Panjang Lighter Wharves (PPLW) which will **cease** operations on **25 June 08**.

2 To ensure a smooth transition of the operations to the new terminal, there will be a parallel run of the operations at Pasir Panjang Lighter Wharves (PPLW) and Penjuru Terminal (PT) for **3 days**, with effect from **22 to 24 Jun 08**.

3 Please note that the Penjuru Terminal will only handle the loading of sea-stores and ships’ spares and the discharge of used ships’ spares. Loading and discharge of any other cargo is strictly **not allowed** at this terminal. For enquiries on the operations at the terminal, please contact Jurong Port at Tel 63162071 or Fax 63162072

4 For the discharge of used ships’ spares, you are required to apply for a TradeNet<sup>®</sup> permit under the Message Type “IN-PAYMENT” and Declaration Type “GST” to pay for the GST.

5 You are required to produce the goods and the permit to the Penjuru Terminal Security Post for endorsement at the time of entering or leaving the Penjuru Terminal. This requirement is stipulated in the permit condition “CP” issued in your approved TradeNet<sup>®</sup> permit:

<b>CP</b>	THE GOODS AND THIS PERMIT MUST BE PRODUCED AT PENJURU TERMINAL SECURITY POST FOR ENDORSEMENT AT THE TIME OF ENTERING OR LEAVING PENJURU TERMINAL.

6 When submitting your TradeNet<sup>®</sup> permit application for sea-stores or ships’ spares brought into and out of Singapore via the Penjuru Terminal, please declare the following Location Code and Location Name with effect from **22 Jun 08**:
