PERMIT LISTING AND PERMIT PRINTING FUNCTIONS IN TRADENET® 4.0

We are pleased to inform you that we have enhanced the permit listing and cargo clearance permit (CCP) printing functions in TradeNet® based on your feedback. The enhancements made are listed in the following tables:

a) Permit Listing

S/N Enhancements made

i. Permit Listing up to 30 days

In addition to the current 7 days permit listing, users can now request for a 30-day permit listing if they choose the e-mail option. Under the e-mail option, the permit listing will be generated offline, and an e-mail alert will be sent to the user's e-mail address when the permit listing is ready for download. Users should take note that they will need to fill in the alert recipient's e-mail address for this option.

ii. New search criteria

Users can now opt to use any the following information as an additional filter criteria:

- Date of approval field
- Importer/exporter UEN
- Permit prefix

iii. Additional information in permit listing

The following information have been included in the permit listing for downloading:

- Flight/ vessel number
- Estimated date of vessel arrival/departure
- Master air waybill/ ocean bill of lading
- House air waybill/ocean bill of lading

iv. New column "Item Total CIF/FOB value"

Under the new column "Item Total CIF/FOB value", users will be able to see the total CIF/FOB value for the items declared in the permit, in addition to the individual item CIF/FOB value.

b) Cargo Clearance Permit (CCP) Printing

S/N Enhancements made

i. Multiple download and mass printing under search by entity identifier/UEN

Users can now download multiple Cargo Clearance Permits (CCP) and print up to 15 CCP at one time. Do take note that selection of the CCP for mass printing is limited to the records shown on the same page.
