### PUBLIC CONSULTATION ON ADVANCE EXPORT DECLARATION

Singapore Customs is seeking public feedback on the implementation of the submission of export declarations prior to export, termed as Advance Export Declaration (AED). We invite you to contribute comments on the proposed amendments. Your feedback is important in helping us improve the implementation details to minimise the impact to trade.

2. Under Singapore's Regulation of Imports and Exports Regulations, an export declaration must be submitted to Customs prior to export of any type of goods. However, for non-controlled and non-dutiable goods that are exported by sea and air, an administrative facilitation was granted in 1976 to allow traders to submit the required export declaration within three days after export.

3. Recognising that implementing AED would impact our trading community, an inter-agency taskforce had conducted formal industry consultations from April 2010 to Dec 2010. We have received useful feedback from individual companies as well as key associations and are conducting this public consultation exercise to obtain further feedback.

4. The public consultation on the implementation of AED is now available and will close by **midnight of 12 April 2011**.
