NOTIFICATION OF TARIFF CHANGES FOR COMPRESSED NATURAL GAS & MOTOR CARS FOR THE TRANSPORT OF TEN OR MORE PERSONS

As announced in Budget 2009, an excise duty of \$0.20 per kgm will be imposed on Compressed Natural Gas (CNG) with effect from 1st January 2012.

2 In addition, to align the duty treatment for motor cars, an excise duty will also be imposed on certain motor cars for the transport of ten or more persons (including their chassis and bodies) from 1st January 2012.

3 Please note the new excise duties and their corresponding AHTN 2012 codes as follows:
