NEW END-USER STATEMENT (EUS) FORMATS FOR STRATEGIC TRADE SCHEME (STS) BULK PERMIT AND INDIVIDUAL PERMIT

This circular informs you of the new End-User Statement (EUS) formats for Strategic Trade Scheme (STS) Bulk Permit and Individual Permit, respectively.

Background

Previously, Singapore Customs has one EUS format for both STS Bulk Permit and Individual Permit. Given the feedback on the diverse nature of business operations involved in strategic goods and the accompanying uniqueness of each business's needs, we have revised the EUS formats for the STS Bulk Permit and Individual Permit so that they can better fulfil the requirements of Customs and businesses.

Revised EUS format for Bulk Permit and Individual Permit

Implementation for EUS format for STS Bulk Permit

4 The EUS format for STS Bulk Permit will be implemented with immediate effect. All STS Bulk Permit holders will have to get their new end users to use the new EUS format for their STS Bulk Permits. Existing end users will have to use the new EUS format for STS Bulk Permit whenever there are changes to the details in the EUS (for



example, change in address) or when the STS Bulk Permit holders renew their STS Bulk Permits, whichever comes first.

5 In addition, this new EUS format for STS Bulk Permit will supersede any facilitations with regard to the previous EUS format that had been granted before 1 Jan 2015.

Implementation for EUS format for STS Individual Permit

6 All STS Individual Permit applications submitted from 1 Jul 2017 will need to be submitted with the new EUS format for Individual Permit.
