[All declaring agents are requested to inform the importers on the contents of the circular.]

Dear Sir/Madam

SUBMISSION OF CERTIFICATE OF ORIGIN (COO) FOR FOOD PRODUCTS FROM JAPAN

In view of the possible risk of radioactive contaminants in food products from Japan, AVA has suspended import of certain food products from 10 prefectures in Japan. Import of certain food products from other prefectures from Japan are currently under hold and test.

In order to facilitate import clearance, AVA will be requesting for every consignment of affected food products to be accompanied with a certificate of origin (COO). Products that require certificate of origin include milk and milk products, meat, seafood, fruits and vegetables (fresh and processed) and seaweed.

The Japanese authority, Ministry of Agriculture, Fishery and Forestry (MAFF) as well as each prefectural government will inform this new procedure to the exporters through their own website. The MAFF also has informed the national council for export promotion of agriculture, forestry and fisheries products of this procedure. Your suppliers can contact any prefectural governments if they want to enquire on the procedures. For fishery products, exporters can apply for the certificate from the Fishery agency in Tokyo.

Regarding the certification of shipments with products from several prefectures, MAFF has informed that each prefectural government will issue the certification even if the products from other prefectures are included.

MAFF has also informed that the prefectural government offices are not open for public holidays and weekends. For imports on public holidays and the weekends, your suppliers should work with the prefectural government to expedite the processing.

Please declare the prefecture origin accordingly in your permit declaration and fax in a copy of the COO for our verification. A sample of the COO is attached for





your easy reference. The submission of COO would be mandatory for all import with effect from 29 Apr 2011.
