## SUSPENSION AND HOLD AND TEST OF CERTAIN FOOD PRODUCTS IMPORTED FROM TAIWAN

Please refer to our circulars dated 3, 7 and 13 June 2011.

- 2 AVA has been testing beverages, jams and jellies manufactured in Taiwan, for phthalates, in view of the phthalate contamination situation in Taiwan. All consignments of beverages, jams and jellies imported from Taiwan are subjected to "hold and test". This means that only products that have cleared AVA's tests for phthalates will be released for sale. Products that fail our tests will be suspended from import. Please find in Annex the list of brands that have been suspended from import. - 3 AVA inspectors will be contacting you to collect samples for testing purpose. You may also contact our inspectors at the following numbers to arrange for inspection or if you require further clarification. Thank you.
