# NEW REQUIREMENT- REGISTRATION OF FOOD STORAGE WAREHOUSE IN SINGAPORE

1 With effect from 1 November 2011, all food storage warehouses are required to be registered with AVA. AVA defines "food storage warehouse" as any building, facility, structure, or premise, in whole or in part, where food is stored for the sale or distribution to other processors, wholesalers or any other business selling or distributing to the ultimate consumer. A "*warehouse operator*" will be defined as a person engaged in the business of operating or controlling a food storage warehouse

2 Warehouse operators will be required to apply with AVA for the "Registration to Operate a Food Storage Warehouse" online, via the Online Business Licensing Service (OBLS) at <a href="https://licences.business.gov.sg">https://licences.business.gov.sg</a>

3 We will be conducting the registration according to the category of food stored and their inherent food safety risk level as shown below:

Categories	Example of Products in this category	Registration Period
I (High Risk Products)	Cheese, butter, ice cream and infant/baby food	November 2011 to January 2011
II (Chilled & Frozen Food)	Juices, pastries, desserts and soups	February 2012 to April 2012
III (Food requiring cool storage environment)	Spices, dried goods, chocolates, chocolate confectionery, sauces, cereals, jams, spreads, coffee beans, tea leaves, shelled eggs, egg products and alcoholic beverages.	May 2012 to July 2012

IV	Instant noodles, snacks, nuts,	
(Food usually stored	canned food products, rice, edible	August 2012 to October 2012
at ambient	fats and oils, food ingredients and	August 2012 to October 2012
temperature)	bakery products
