### **Importer Registration**

4 Food importers are required to register with AVA (QID) (processed food), and apply for an import permit in order to bring the food products and food appliances (as stated in paragraph 2) into Singapore for sale. Importers can register online at the following website, <a href="http://www.ava.gov.sg/Services/LicensesPermitsAndCerts/">http://www.ava.gov.sg/Services/LicensesPermitsAndCerts/</a> (Under "Food Sector", go to No.15).

### Other matters

- Please also be reminded that some product codes require declaring agents to (a) specify the <u>production process of the product</u>, e.g. for milk products whether they are pasteurised, sterilised or UHT etc, or (b) to specify the <u>exact types/species of the product</u>, e.g. for product "vegetable, single", the type of vegetable has to be specified, such as whether it is watercress or cauliflower or spinach etc, in the "product description" field of the permit declaration. We seek your cooperation to declare appropriately, so as to assist us in monitoring the import of these food products.
