Dear traders and declaring agents

SUBMISSION OF SUPPORTING DOCUMENTS FOR TRADENET DECLARATIONS FOR IMPORT, EXPORT & TRANSHIPMENT OF WILDLIFE PRODUCTS (INCLUDING CITES-LISTED PRODUCTS)

One of the features in TradeNet system is to allow users to attach supporting documents electronically together with your TradeNet declarations or via the portal after sending your TradeNet declarations for the competent authorities [Agri-Food & Veterinary (AVA)] or Singapore Customs (SC) etc. to process your declarations.

We would like to inform you that with effect from <u>1 October 2012</u>, all submission of supporting documents for declaring import, export and transhipment of CITESⁱ and wildlife specimens or consignments through the TradeNet system must be in electronic formats. The AVA (CITES) will no longer accept hardcopy submission of supporting documents. Please attach relevant supporting documents in your TradeNet declarations as follows:

a) For import/export declarations

Invoices, packing lists, Airway bill/Bill of Lading; and For CITES species — you need not attach soft copies of the CITES permits. However, please ensure that you declare the AVA CITES permit no. in the TradeNet declaration correctly.

b) For transhipment declarations

Invoices, packing lists, Airway bill/Bill of Lading; and For CITES species – CITES export/re-export permit from exporting/re-exporting country and *CITES import permit from country of destination (*for CITES Appendix I species)

- 3 Declarations submitted to the AVA (CITES) without the required supporting documents in electronic format would be rejected. Please note the following when submitting electronic supporting documents in TradeNet system:
- i. Up to 6 supporting documents can be attached for each declaration
- ii. File formats that are allowed to be attached are:
 - 1. MS Word
 - 2. MS Excel
 - 3. Adobe PDF

- 4. Image Files:
- a. Bitmap
- b. JPEG
- c. GIF Image
- d. EMF Image
- e. PNG Image
- f. TIF Image
- iii. Should you require any assistance on the process of attaching the supporting documents to your TradeNet declarations, please consult your TradeNet Front-end solution provider.
