#### REQUEST FOR IMPORT / EXPORT/ TRANSHIPMENT OF ARMS AND EXPLOSIVES

Since 25 July 2011, Police Licensing & Regulatory Department (PLRD) has stopped issuing any inprincipal approval for applications to import / export / transshipment of arms and explosives. Instead, a request form is to be submitted to PLRD and this will be processed via your submitted applications ie import, export and transshipment applications in the TradeNet system.

- When your company has a consignment to be imported / exported / transshipped, you shall submit your request to us using the **Request Form**, together with the following supporting documents, to our office via fax or post to the above address for our consideration:-
- (a) End User Certificate:
- (b) Invoice;
- (c) Manifest or Packing List;
- (d) Bill of Lading or Airway Bill;
- (e) Material Safety Data Sheet (MSDS for Explosive Precursors only); and
- (f) Import Licence or Approval letter from government authorities of final destination.
- 3 Upon submission of the Request Form to PLRD, the applicant or his appointed freight forwarder shall ensure that his TradeNet application is submitted in the TradeNet system. Please note that the TradeNet Unique Reference No. is a compulsory field in the Request Form. (Note: The unique reference number is issued by the TradeNet system and consists of 3 data elements. They are your Unique Entity Identifier or UEN, the date of submission and the Sequence Number. Eg 291436746W 20110128 3003.)
- 4 Our general processing timing for TradeNet is <u>5 working days</u> upon receipt of all supporting documents. Applicants may however do a check on their application status from the TradeNet System from the next working day onwards. For applications where the status is stated as pending processing or rejected in the TradeNet System, applicants are to log into the system to find out the details. Please refer to <u>Annex A</u> for a collated a list of common errors in the TradeNet application submission.
- 5 Lastly, applicants are reminded to comply with conditions pertaining to the Import and Export of Arms, Explosive and Explosive Precursors.
