## INCLUSION OF NEW WILDLIFE AND TIMBER SPECIES ON CITES APPENDIX III

Singapore is a Party to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), which is an international agreement to ensure that trade does not threaten species with extinction.

2 The Agri-Food and Veterinary Authority (AVA) would like to inform you about the inclusion of several new mammals, birds and timber species on CITES Appendix III, by Nicaragua, Pakistan and the Russian Federation:-

3 Please note that the listing of the species in CITES shall enter into operation from <u>24 Jun 2014</u>. For TradeNet declarations, please use the current HS and product codes for <u>mammals and birds</u>

As your company may have trade (import and export/re-export) in some of the species, particularly timber species, please declare the existing stocks in your possession using the relevant declaration form in **Annex B** if your company has existing stocks of the species. The completed form must be returned to AVA by <u>24 Jun 2014</u>. The declaration of pre-Convention stock is to facilitate the issuance of CITES re-export permit after 24 Jun 2014.
