**Import and Veterinary Conditions for Frozen Poultry from Thailand**

- a) Import of frozen poultry from AVA-approved poultry establishments;
- b) Veterinary health certification on a system of traceability to ensure that broilers must only be sourced from DLD-regulated poultry farms in Thailand;
- c) Veterinary health certification of freedom from H5 or H7 Avian Influenza (AI) in 10km radius surrounding the slaughterhouses and export farms for the last three(3) months, and that these export farms do not practise AI vaccination;
- d) Veterinary health certification attesting to official veterinary supervision in the slaughterhouses and export farms for compliance to biosecurity measures and disease reporting;
- e) Veterinary health certification attesting that active H5 and H7 AI surveillance<sup>1</sup> is being conducted by official veterinarians at the farm during the poultry production cycle, at the buffer zone, and that every consignment of poultry for export have been tested negative for H5 and H7 AI prior to export, as follows:
  - i. Each chicken slaughterhouse is required to conduct pre-export H5 and H7 AI testing for 20% of its source farms.
  - ii. Each duck/geese slaughterhouse is required to conduct pre-export H5 and H7 AI testing for 100% of its source farms.
- f) Other certification requirements for export of meat and meat products from Thailand to Singapore<sup>2</sup>.

<sup>1</sup> Random sampling of cloacal swabs from live birds of the farms will be tested for NAI H5 and H7 viruses using either PCR or Egg Inoculation methods that are conducted at the National Institute of Animal Health of DLD. The tests should be conducted prior to the export of the poultry products to Singapore with the summary copy of the test results to accompany the veterinary health certificate.

<sup>2</sup> These refer to the certification requirements already in place for the export of heat-treated processed poultry products, excluding the condition referring to time-temperature heat treatment.
