## **CIRCULAR**

To All Traders of Dumplings/Pasta Containing Seafood (All traders are requested to inform your declaring agents of the contents of this circular)

Dear Sirs

CHANGE OF HS CODE AND PRODUCT CODES FOR THE DECLARATION OF DUMPLINGS/PASTA STUFFED WITH FISH, CRUSTACEAN OR MOLLUSCS, NOT CONTAINING MEAT

Currently, the import of dumplings/pasta stuffed with fish, crustacean or molluscs, not containing meat, is declared using AVA processed food registration number with HS/AVA Product code: 1902 2030 / ZPPØDBØØØJK to apply for the import permit.

AVA had reviewed and re-classified these food products as <u>fish and fish</u> <u>products</u>, instead of processed food in general, and the following new import procedures will be implemented with effect from <u>1 October 2017</u>.

- (i) Cargo clearance permits for import, export and transhipment of dumplings/pasta stuffed with fish, crustacean or molluscs, not containing meat, are to be declared using AVA Licence for Import/Export/Transshipment of Meat and Fish products, instead of AVA Registration Number for Import of Processed Food and Food Appliances.
- (ii) Traders who do not hold a valid license for Import/Export/Transhipment of Meat and Fish products importers are to apply for the licence online at the following link (<a href="https://licence1.business.gov.sg/AVA/authentication/showLogin.action">https://licence1.business.gov.sg/AVA/authentication/showLogin.action</a>.) before the implementation date. The licence fee of \$84 per annum and is subjected to annual renewal. Please note that the license number is required for permit application.
- (iii) AVA permit fee to import/export/transship fish and fish products is \$3 per permit.





(iv) As a result of the review, please note the following changes in HS codes, AVA product codes and product descriptions.

- (v) The above list of new HS codes and AVA Product codes for dumplings/pasta stuffed with fish, crustacean or molluscs, not containing meat (previously from processed food category), will be reflected under the Fish and Fish products' product code list.
- As dumplings/pasta stuffed with fish, crustacean or molluscs, not containing meat, will no longer be declared using the processed food registration number with HS/AVA Product code: 1902 2030 / ZPPØDBØØØJK with effect from 1 Oct 2017, this product code will be removed from the "Processed Food" product code list, and from the TradeNet system.
