ADDITIONAL **HAZARDOUS SUBSTANCES** CONTROLLED UNDER THE ACT **ENVIRONMENTAL PROTECTION** MANAGEMENT AND AND **ENVIRONMENTAL PROTECTION** AND MANAGEMENT (HAZARDOUS **SUBSTANCES) REGULATIONS**

With effect from <u>30 June 2018</u>, polychlorinated naphthalenes, short-chain chlorinated paraffins and trichlorfon will be controlled as hazardous substances by the National Environment Agency ("NEA") under the Environmental Protection and Management Act ("EPMA") and EPMA (Hazardous Substances) Regulations.

- The manufacture, import and export of polychlorinated naphthalenes and short-chain chlorinated paraffins, as well as products containing these chemicals will not be allowed. Companies with existing stock of the chemicals and/or their products imported before 30 June 2018 are allowed to deplete the stock.
- A Hazardous Substances Licence will be required for companies that manufacture, import, export and sell trichlorfon and products containing trichlorfon. End-users that store and use trichlorfon and/or their products will be required to obtain a Hazardous Substances Permit.

Harmonized System ("HS") and Product Codes

- The list of HS and Product codes are listed in **ANNEX A**. With effect from 30 June 2018, traders are required to declare the import and export TradeNet[®] permit applications using the appropriate HS and Product codes. All such TradeNet permit applications will be subjected to Pollution Control Department's (PCD) processing and approval.
