Singapore Customs seizes 53.2kg of duty-unpaid “Ang Hoon”

Singapore Customs officers arrested two Chinese nationals, a 48-year-old man and a 42-year-old woman, and seized 53.2 kg of duty-unpaid “Ang Hoon” (tobacco used to make hand-rolled cigarettes) in an operation on 31 May 2021.

Detection on 31 May 2021

A freight forwarding company handling the import of air consignments detected discrepancies in one of such consignments. The company found two boxes containing duty-unpaid “Ang Hoon” packed in plastic packaging labelled as ‘tea leaves’ instead of plastic cases as stated in the consignment note and alerted Singapore Customs.

Following up on the information, Singapore Customs officers mounted an operation in the vicinity of Lorong Chuan and checked a man who had collected the consignment. The consignment containing duty-unpaid “Ang Hoon” was found at the staircase landing at his place of residence. Singapore Customs officers also found rolling papers, filters, and a cigarette rolling kit in a follow-up search in his residence.

The man was arrested, and a woman, who was allegedly the intended recipient of the consignment, was also subsequently arrested. Court proceedings are ongoing against both individuals.

The operation resulted in a seizure of 53.2kg of duty-unpaid “Ang Hoon”. The total duty and Goods and Services Tax (GST) evaded amounted to about \$17,500 and \$1,310 respectively.

Call to forwarding companies to be alert to illicit activities

“We urge freight forwarding companies to be vigilant against suspicious consignments and to alert the authorities to prevent their services from being exploited for illicit

activities,” said Head of Intelligence Branch Mr. Yee Kwan Yew. ([新加坡关税局情报处处长余均耀]).

Buying, selling, conveying, delivering, storing, keeping, having in possession or dealing with duty-unpaid goods are serious offences under the Customs Act and the GST Act. Offenders can be fined up to 40 times the amount of duty and GST evaded and/or jailed for up to six years.
