To Traders, Declaring Agents and Shipping Agents

**CORPPASS WILL BE THE ONLY MODE OF LOGIN FOR COMPANIES TO  
TRANSACTION WITH SINGAPORE CUSTOMS FROM Q3 2018**

Further to our Notice No. 07/2016 issued on 2 Sep 2016, Notice No. 03/2017 issued on 13 Feb 2017 and the [media release](#) by the Government Technology Agency of Singapore (GovTech) issued on 18 Dec 2017, we would like to remind you that from Q3 2018, the Singapore Corporate Access (or CorpPass) will be the only login method for companies to transact with the Government.

2 Existing users of Singapore Customs e-Services should register for CorpPass to access Singapore Customs e-Services to avoid any inconvenience in the future when the current mode of login will no longer be available. After you have registered for CorpPass, please log in to the following e-Services where applicable:

- a) **Customs Account / Declaring Agent Account / Authorisation of Declaring Agent:** For companies that have activated Customs Account and/or have a Declaring Agent (DA) Account, the Key Personnel and the Authorised Personnel should log in to this e-Service with CorpPass to ensure that their company and contact details are updated.

- b) **Government TradeNet Application and Services:** Existing TradeNet users should log in to TradeNet e-Service with CorpPass for the conversion process. After log in, users would be required to select the TradeNet ID that is issued under the same Unique Entity Number (UEN) as their CorpPass.

(Existing users of TradeNet front-end solutions can continue to use their existing IDs to access the TradeNet front-end solutions.)

- c) **Inventory Control System and Petroleum Refund:** Existing users may log in using eCustoms ID or SingPass and perform the conversion process to CorpPass before they can log in with CorpPass.

eCustoms/SingPass login → CorpPass Account Conversion page will be displayed → Click “Convert Now” → Re-direct to CorpPass portal to log in using CorpPass ID, company UEN and password → Message will appear on CorpPass Account Conversion page on whether the conversion is successful.

- d) **Web Manifest Reconciliation Statement (WMRS):** Existing users should log in to WMRS using CorpPass to submit Manifest Reconciliation Statements and to update their particulars.
